SECOND AMENDMENT TO THE REGISTER OF DEEDS DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR BENT CREEK ACTIVE ADULT COTTAGES

THIS SECOND AMENDMENT ("Second Amendment") TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR BENT CREEK ACTIVE ADULT COTTAGES made this the [3] th day of November, 2015, by **CK DEVELOPMENT**, **L.L.C**, a Tennessee limited liability company (hereinafter referred to as "Declarant"), for itself, its successors, successors-in-title, grantees, and assigns.

WITNESSETH:

WHEREAS, Declarant previously established certain covenants, conditions, and restrictions for property located in Nolensville, Williamson County, Tennessee, pursuant to the Declaration of Covenants, Conditions, and Restrictions (the "Original Declaration") for Bent Creek Active Adult Cottages (the "Subdivision") of record in Record Book 6357, Page 556, in the Register's Office for Williamson County, Tennessee (the "Register's Office"), as amended by the First Amendment to the Declaration of Covenants, Conditions, and Restrictions for the Subdivision of record in Record Book 6360, Page 319, in said Register's Office (the "First Amendment"; the Original Declaration together with the First Amendment may be collectively referred to herein as the "Declaration"); and

WHEREAS, pursuant to Article XII, Section 1(a) of the Declaration, Declarant desires to unilaterally amend the Declaration prior to the termination of the Class "B" Control Period as set forth herein for purposes of making said section consistent with the Fair Housing Acts.

NOW THEREFORE, for and in consideration of these premises and other and valuable consideration, the Declarant hereby amends the Declaration as follows:

- 1. Article XII, Section 1(b)(ii) of the Declaration shall be substituted and replaced with the following new subclause to clarify the restrictions with respect to Unit occupancy:
 - (ii) No Unit shall be occupied by any person under the age of forty (40). In addition, unless otherwise permitted by the Board, no Unit may be occupied by more than two (2) persons. For purposes of this Article, a Unit shall be deemed to be "occupied" by any person who stays overnight in the Unit more than twenty-one (21) days in any sixty (60) day period or more than forty-five (45) days in any twelve (12) month period. Notwithstanding the foregoing, the restrictions set forth in this clause (ii) shall in no way be construed to restrict the occupancy of Units in a manner that would be considered discriminatory under any provisions of the Fair Housing Acts or any other applicable local, state, or

federal laws.

- 2. All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Declaration, as modified, supplemented and amended from time to time.
- 3. All other items not heretofore amended shall remain in full force and effect.
